

AGREEMENT OF SALE

This agreement is made and entered into this ____th day of _____ 20____, by and between East Park Research, a Nevada Corporation, SELLER (hereinafter referred to as **EAST PARK**) and _____ an independent contractor (hereinafter referred to as **BUYER**). EAST PARK and BUYER shall be collectively referred to as **ALL PARTIES**.

EFFECTIVE DATE

This document is intended to be a binding contract for the sale of East Park's products as more fully described in the attached invoice. This document will be executed in multiple form and the date that the signed copy is received by East Park shall constitute the operative date of acceptance. This Agreement may be terminated at any time by written notice to the other party.

COMPLIANCE WITH LAWS AND REGULATIONS

Buyer hereby agrees that in their selling of the Product they will make no representations, or warranties about the product other than those contained in the literature supplied by East Park Research and that they have complied with all Federal and State rules and regulations in its conduct of business in the sale of the Product. East Park shall not be responsible for any representations or warranties made by Buyer about the Product, and East Park shall not be responsible for any injury to any person or property arising out of the improper dissemination or re-distribution of the Product.

AGREEMENT NOT TO RE-LABEL OR RE-PACKAGE

Buyer hereby agrees that they will not re-package or re-label the Product without prior written consent of East Park.

PRIVATE LABEL AGREEMENT

Company agrees to purchase a minimum of 1,000 bottles for one calendar year. Private label customer assumes all risks and indemnifies East Park Research, Inc. from any trademark or patent infringement claims resulting from the use of artwork, lettering, or other material.

MONEY BACK GUARANTEE

East Park Research's satisfaction guarantee is to the end user.

NON-DISCLOSURE AND NON-COMPETE AGREEMENTS

Buyer hereby agrees and acknowledges that the Product is a proprietary and intellectual property right owned exclusively by East Park. In the event East Park deems it necessary to include a non-disclosure and non-competition agreement, then that agreement shall become operative upon receipt of the product.

TERMS OF AGREEMENT

Buyer agrees to pay any amounts owing upon receipt of the invoice. The purchase price shall be in accordance with the price sheet issued by East Park, which may be changed without notice.

NOW THEREFORE, in consideration of the above recitals (all of which are true and shall be deemed to be incorporated into the interpretation and construction of this Agreement) and the mutual promises, covenants, terms and conditions contained herein, the parties hereto agree as follows:

1. This Agreement and legal relations between the parties shall be governed by and construed in accordance with laws of the State of Nevada. Legal action (if any) must be filed in Clark County, Nevada.
